MEMORIAL FUND

The Memorial Fund is the Senior Men's Club largest financial asset currently with a value of over \$54k. The Fund is covered in the Club's Procedure Manuel on-line, but we know little of the genesis and the history of the Fund. We do know that under \$25k was placed in an investment account held separately by the Club in 2012. Prior to that we believe the Fund was invested in Bank CD's. We are unaware of any amount of the Memorial Fund being used since 2012 or money added to the fund since 2012 except for dividend income and market gains. The Executive Board has asked a subset of the Finance Committee to look into the history of the Memorial Fund and to make a recommendation on how the funds should be used. To that end, if anyone has any information as to the original donors, what the donors had in mind when they made the donations, when those donations were made, and in what amounts, please contact John Skubik (skubikj@yahoo.com) or Jim Suhay (jsuhay@sbcglobal.net).

SMC Finances in Excellent Shape

Thanks to the faithful stewardship of Treasurer Jim Suhay and Assistant Treasurer John Skubik, I am pleased to report that the financial viability of the club is in excellent condition.





Beginning last October, following their election, Jim and John began a painstaking review

of the Club's recent financial history. In January, they presented a detailed 2021 proposed \$27k budget that the Executive Board approved. Since then, they have presented monthly reports to the Board tracking that budget. Through April, we have a surplus of nearly \$1k cash.

Among their most significant achievements has been restoration of the Club's tax exempt status. In 1986, the IRS determined we were a 501c7 tax exempt social club. Nine years later, following a review of our books and records, IRS ruled we were a 501c4 social welfare organization. Last May the IRS revoked that status because we had inadvertently failed to file required IRS 990 notices. Jim and John, working with the CPA firm Plante & Moran, contacted the IRS and made the necessary filings. In March, the IRS reinstated our tax exempt status as a 501c7 social club. No fines or penalties were assessed. Going forward, Jim and John have instituted safeguards to assure this situation never occurs again.

Now that our tax exempt status has been renewed, Jim and John are leading a review of the Club's Memorial Fund, as described in their accompanying article. They are also securing quotes for Director & Officer liability insurance coverage, which most other tax exempt nonprofits maintain.

Together they have spent nearly 100 hours over the past six months tending to the Club's finances. Please join me in offering our most sincere thanks.



Classic Movie Group

The Classic Movie Group feature for Monday, June 14 at 1:00 PM, will be *Red Tails* (2012) (2 hours and 5 minutes). This film tells the real-life story about a crew of African-American pilots in the Tuskegee training program, who, having faced segregation while kept mostly on the ground during much of World War II, are finally called into duty. These men formed the 332nd Fighter Group, an all African-American World War II unit made up of the best escort pilots, and known as the *Red Tails*, fight racism at home while fighting the Nazis abroad in this action-packed drama based on the true story of the Tuskegee Airmen. The *Red Tails* cast is large and distinguished, led by Terrence Howard and Cuba Gooding Jr.

Producer George Lucas began developing *Red Tails* around 1988, after hearing of the Tuskegee Airmen from a friend. Lucas originally conceived of the film as a long, detailed narrative, similar to *Lawrence of Arabia*, and in a trilogy format, but after multiple script drafts, he decided to focus on the combat portion of the story. The result is an outstanding war-time motion picture you will not want to miss.

In addition to the movie presentation, Lt Col Harry Stewart, one of the twelve remaining members of this distinguished group of WWII combat aviators, will join us for our group discussion at the conclusion of the film. As many of you know, he has previously spoken to the Senior Men's Club about his service with the 332nd Fighter Group.

We will be showing this action-packed WW II movie, via Zoom, on Monday, June 14 at 1:00 PM. So, put this date on your calendar and join us for what promises to be an entertaining afternoon at the movies.

As always, we are grateful to Roger Timm for serving as Zoom master for both book groups.

Wednesday, June 2, at 10:30 AM: The Mantle of Command: FDR at War, 1941-1942 by Nigel Hamilton. New York: Houghton Mifflin, 2014.

This is the first of Hamilton's three volume study of Franklin Roosevelt's role as commander in chief during World War II. It provides an up close and personal view of FDR's battles with Churchill, the Secretary of War, and sometimes his own generals about the conduct of the war. *The New York Times* reviewer wrote, "*The Mantle of Command* is splendid; it's the memoir Roosevelt didn't get to write." Roger Timm will lead this session.

Monday, June 21, at 3:00 PM: The Splendid and the Vile: A Saga of Churchill, Family and Defiance During the Blitz by Eric Larson. New York: Crown, 2020.

Larson brilliantly tells the story of Winston's Churchill first year as Prime Minister when England was facing its "darkest hour". It is no surprise that it spent many weeks on the NY Times Best Sellers list. *The Rolling Stone* reviewer called it "A damn good story. There are narrative arcs, heroes, villains, and suspense aplenty to craft the kind of rich, immersive histories that have become Larson's trademark." *The Wall Street Journal* review wrote, "Larson's book offers a delicious slice of life of the world's last great statesman." This discussion will be led by Jon Haber.
