The Senior Men's Club has more than 750 members, with an average age of nearly 80. It is therefore no surprise when we experience the loss of a member. After all, more than 30 members passed away last year.

What is shocking, however, and difficult to accept is when a seemingly healthy and very active member passes on suddenly. This is what happened with Ken Nagley, who developed complications following mid-December surgery and died so quickly. With our holiday

hiatus, most of us were unaware of his serious health situation.

When Dr. Delevie told us how serious it was at the meeting on January 13, a wave of shocked disbelief echoed through our meeting room. Ken died the next day.

Without a doubt, Ken Nagley was one of our most active, well known, and widely admired members. He became an active member in 1991, after a highly successful career as an educator, including serving as the first principal of Groves High School. As a club member, he served on a multitude of committees, including Attendance, Hospitality and Programs. He was simply always there, seldom missing a Friday meeting. His many contributions to our club were recognized with the awarding of our highest honor - the Outstanding Service Award in 2001.

Cowboys and Indians

One of March's Golden Oldies candidates has led an incredible life that would make a great script for a John Wayne movie. George Mosher was born in Hot Springs, South Dakota. He grew up as a cowboy on a family ranch in the Black Hills near Pine Ridge Cheyenne Indian Reservation. He attended a one room country school with 15 students and one teacher who taught all eight grades. In 1937, during the Dust Bowl days, his dad lost the ranch and the family loaded up their belongings and moved to Oregon.



George graduated from the University of Oregon in 1943 and became a Lt. (jg) in the Navy. After Midshipman School at Northwestern University he served on Destroyer Escorts in the Atlantic and Pacific, and participated in the invasions of Guam, Saipan and Okinawa. In 1948 George graduated from Columbia Law School, was admitted to the New York Bar, and began the practice of trademark law in New York City. In 1954 he joined the legal staff of General Motors as the attorney in charge of trademarks. After 32 years he retired and joined the law firm of Brooks Kushman in Southfield. In 1964 George was elected to the first Board of Trustees to establish a community college in Oakland County. He became the first Chairman of the Board and a founder of the college. Within 16 months Oakland Community College was opened on two campuses to 4,000 students. Today O.C.C. has five campuses and is the fourth largest college in the state of Michigan with about 27,000 students. The George R. Mosher Library on the Auburn Hills campus was named in George's honor.

We are proud to welcome George to our Golden Oldies with all the honors and privileges that go with that special status.

Infantry and Cavalry

Battles between the Infantry and the Cavalry were fought in Birmingham in the early 1930's in little known stories told by Will Braisted, a life long resident of the area and this month's candidate for the Golden Oldies. Will was a charter member of Quarton School, continuing on to Baldwin School for the seventh through twelfth grade. The neighborhood kids played in the woods west of Covington where Will and his buddies acted as the Infantry, and the Peabodys were the rival Cavalry. When the Cavalry blew the



top off the chimney of the hand built log cabin, it was considered an act of war. The battle didn't last long. When one of the boys shot his buddy through the lung, the parents got involved, the cabin was torn down and a lasting peace declared.

Will entered the University of Michigan in 1939. In 1943 he was drafted into the Army and shipped to Fort Sill. After basic training, Will was sent to Fort Ord where he was trained in fire control. His crew left for New Guinea and the beachhead on Luzon. His unit set the record for continuous combat of 190 days. He ended his service by joining the CID. When Will returned to U of M he again was a walk-on tryout for football. He had played for Michigan before the Army, but was cut from the team when he tackled Fritz Crisler. This time he made the second team for two hours when he got a concussion that ended his sports career.

Will graduated with a degree in BS in Mechanical Engineering, and was hired by Vickers. Among his assignments was joining a group to redesign the Sherman Tank. He moved on to Chrysler Missile Division where he worked on the Redstone Missile. His next career move was to join his father as a Manufacturer's Representative for electrical distribution equipment and after 32 years he retired. The Golden Oldies are proud to welcome this home town boy to their midst.

EXECUTIVE BOARD ACTIONS

Two subjects dealing with Friday meeting procedural guidelines were discussed by the Executive Board. First, John Slocum, co-chairman of the Visual and Photography Committee discussed the problem with A/V equipment encountered at the meeting on February 10, 2005.

SMC operating guidelines for monthly program chairmen call for the communication of visual equipment needs and plans both to the Chairman of the Visual and Photography Committee and The Community House a week in advance of a scheduled presentation. In addition, a pre-presentation test run of equipment/connections is called for, to take place no later than 10:00 a.m. on the presentation date. Further, the speaker or a representative is expected to be present for this connection test.

Unfortunately, these guidelines were not followed on February 10. Despite the best efforts of the committee and Community House staff, the A/V equipment would not function.

General Program Chairman Ken Urwiller will be asked to recommunicate these critical planning guidelines to all individual monthly chairmen, including the importance of speaker participation or representation at the pre-meeting equipment testing.

Secondly, Ken Brooker, co-chairman of the Audio Committee, requested a guideline with respect to the use of microphones during the question and answer period of Friday presentations. He noted that on occasion, members would voice a question without having the microphone, disrupting the flow of the meeting. In addition, most of the audience could not hear the question.

After some committee discussion, it was agreed that questions would only be taken from those with a microphone provided by a committee member. The presiding officer is responsible for enforcing this guideline, which will be announced at subsequent Friday meetings, and reported in *The Reminder*.






